The broad terms and conditions are as follows.

1. That the Generator is to be installed at his own place without creating any notices which may cause disruption to the regular works of the Bank Branch and its customers.
2. That the owner of the Generator should take all the initiatives to control sound pollution and if required NOC is to be obtained by the Service Provider from the Appropriate Authority.
3. That the Maintenance charges/ Fuel charges /other all charges will be borne by the Service Provider.

4. That the Service is to be rendered normally from 9.30 am to 7.00 pm. In exigency the time may be extended beyond normal time. During the time of electric power fail /low voltage of the said generator, substitute arrangement connecting all point a whether existing or which may at any point of time hereafter exist or be added/reconnected by way of installation of additional computers and or addition of electric points for lights, fans, other electrical fittings & appliances, is to be made as alternative by the said provider at his own cost.
5. That operation of the Generator is to be done by the service provider himself or arrangement of alternative 2nd Generator is to be made by the service provider.
6. That the owner of the generator will have to maintain a logbook mentioning period of operation of the generator along with specific period under power cur/dropped voltage etc and the log book is required to be signed /authenticated by the Branch Manager.
7. That the service provider shall not let out or allow any other person to use the power from generator hampering the requisite supply of generator to the Bank.
8. The lowest bidders will be considered and communicated accordingly.
9. The arrangement will be valid for 3 years from the date of agreement.
10. The tenders are to be addressed to the Branch Managers of the respective branches within 25th June 2014.
